

**REFERENDUM PETITION (REPEAL OF ORDINANCE No. 3519)**

To: Municipal Clerk and the Council of the Village of Ridgewood, Bergen County:

We, the undersigned registered voters of the Village of Ridgewood, County of Bergen, State of New Jersey, seek to protest and repeal Ordinance No. 3519 -- An Ordinance Authorizing the Execution and Granting of a Lease Purchase Agreement with the Bergen County Improvement Authority Relating to the Issuance of County Guaranteed Lease Revenue Bonds for the Village of Ridgewood Parking Deck Project--- consisting of 4 pages, which is annexed hereto and made part hereof, under the power of referendum granted to voters of the Village of Ridgewood by N.J.S.A. 40:69A-185 or N.J.S.A.40:49-27. If the same is not repealed by the Township Council within the time prescribed by N.J.S.A. 40:69A-184 et seq., the undersigned voters demand that the same be submitted to the electorate for a vote at a special election in accordance with N.J.S.A. 40:69A-184 et seq., or the next general election in accordance with N.J.S.A. 40:49-10, which ever is applicable, with the question to be put to the voters in this manner:

Shall Ordinance No. 3519 authorizing the Council of the Village of Ridgewood to (i) apply to the Bergen County Improvement Authority to fund the construction of a parking garage, which would be financed and constructed by that authority and (ii) to subsequently lease that parking garage from the Authority once built, where the Council could not achieve the supermajority needed to issue the bonds to construct that garage itself, be adopted or ratified?
